Note: Excerpts pertaining to qualifications of the Elected Directors from Article 4.2.5 of the Third Amended and Restated Constitution of the Hindu Society of North Carolina are included below.

(It is essential that the first and last names of the candidate match those appearing in the HSNC Members database)
- ii. A Director shall not have any criminal conviction other than minor traffic incidents such as speeding tickets and parking tickets
- iii. No Director shall serve consecutive terms
- iv. The spouse of any Director cannot simultaneously serve as a Director.
- v. A Director cannot serve as a chairperson of any committee of the Society.
